- (1) This represents the difference between the number of SARs exercised (3,000) and the number of shares issued as a result of the exercise (1,692). The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date of exercise (\$64.32) and the exercise price (\$11.92). Additional shares are then withheld to satisfy the Company's tax withholding obligations.
