On October 31, 2014, Kimberly-Clark Corporation ("Kimberly-Clark") distributed all of the outstanding shares of common stock of Halyard Health, Inc. ("Halyard") to its stockholders in a previously announced pro rata distribution. Prior to the distribution, Halyard issued 48,000,000 shares of common stock to Kimberly-Clark in connection with the contribution of Kimberly-Clarks's health care business to Halyard. Pursuant to a distribution agreement between Kimberly-Clark and Halyard, 46,535,951 shares of Halyard common stock were distributed to Kimberly-Clark stockholders and the remaining shares of Halyard common sock were cancelled by the distribution agent. Additional information about this transaction can be found in Halyard's Registration Statement on Form 10, as amended.
