- (2) The options become exercisable over a 4-year period which commenced on January 31, 2002, as follows: 62,500 shares exercisable as of January 31, 2003, 5208.3 shares every month thereafter for 36 months through January 31, 2006.

The options become exercisable on a monthly basis over a 4-year period which commenced on January 31, 2002, as follows: 10%
