- (1) The sales reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on August 21, 2012.
- (2) The options became exercisable in four equal installments on May 1, 2005, 2006, 2007 and 2008.
- (3) The exercise price increases over the term of the option at a rate equal to the 10-year Treasury bond yield as of the date of grant (\$14.70). On October 15, 2012, the exercise price was \$20.4008.  
The transaction was executed in multiple trades at prices ranging from \$64.00 to \$64.15. The price reported above reflects the weighted average sale price. The reporting person hereby undertakes to provide upon request to the SEC staff, Morningstar or a shareholder of Morningstar full information regarding the number of shares and prices at which the transaction was effected.
