**Clarification about Information Disclosed by the BG Group (BG) with Regard to Tupi and Guará Discoveries**

Rio de Janeiro, December 09 2010    Petróleo Brasileiro S.A. - Petrobras, as the operator of Blocks BMS-11 and BMS-9, clarifies that the announcement issued today (12/09/2010) by the BG Group concerning the estimated volumes of recoverable oil equivalent and the capital and production costs for the projects involved in the initial development phase for these discoveries, is not a disclosure made by the Consortium in charge of operating the blocks. The information is BG's responsibility.

Petrobras, as the operator of the consortium, reiterates the estimates that have already been announced, of 5 to 8 billion barrels of oil equivalent recoverable in Tupi and Iracema (Block BM-S-11), and 1.1 to 2 billion barrels of oil equivalent recoverable in Guará (Block BM-S-9), and reasserts the economic feasibility of these discoveries at price levels ranging from \$35 to \$40 per barrel, in accordance with the variables of its Business Plan 2010-14.

The Company also informs that the disclosure made by BG occurred without the compliance with the rules set forth under the Joint Operations Agreement.
