***“América Móvil announces a proposal for a dividend payment and the amount to repurchase shares”***

**Mexico City, Mexico, March 18, 2014. América Móvil, S. A.B. de C.V. ( AMX ) (BMV: AMX; NYSE: AMX; NASDAQ: AMOV; LATIBEX: XAMXL )**, announced that in today s meeting, its Board of Directors decided to submit to the Annual Ordinary General Shareholders Meeting to be held on or before April 30, a proposal to (i) make a payment of a cash dividend from the consolidated net profit tax account ( cuenta de utilidad fiscal neta consolidada ), of MXP\$0.24 (Twenty four peso cents), payable in two installments, to each of the shares of its capital stock series AA , A" and "L" outstanding as of the date of the dividend payment (which includes the preferred dividend correspondent to the series L shares), subject to adjustments arising from other corporate events (including repurchase or placement of its own shares), that may vary the number of shares outstanding as of the date of said dividend payment; and (ii) to allocate the amount of MXP\$30,000,000,000.00 (Thirty billion pesos), to repurchase shares in accordance with article 56 of the Securities Market Law (Ley del Mercado de Valores ).
