On May 16, 2007, the Board of Directors of Emergent BioSolutions Inc. (the Company) appointed Daniel J. Abdun-Nabi, the Company s president and secretary, to the additional position of chief operating officer. Mr. Abdun-Nabi received an L.L.M. in taxation from Georgetown University Law Center, a J.D. from the University of San Diego School of Law and a B.A. in political science from the University of Massachusetts, Amherst. There are no family relationships between Mr. Abdun-Nabi and any executive officer or director of the Company.

On May 11, 2007, Edward J. Arcuri, Ph.D. notified the Company of his decision to resign as chief operating officer. Mr. Arcuri s resignation will be effective as of May 16, 2007.
