- (1) Mr. Bone is a participant in FNCB Bancorp, Inc.'s Dividend Reinvestment and Stock Purchase Plan ("DRP"). These transactions are the result of his participation in the DRP during September 2017.  
This amount includes 0.0002 shares acquired individually by Mr. Bone; 64,848 shares acquired jointly with Mr. Bone's spouse; and 18,249 shares acquired jointly with Mr. Bone's father and siblings. Therefore Mr. Bone owns 15,420.808 shares held jointly with his spouse; 13,556 shares of time-based restricted common stock solely owned by Mr. Bone; 4,759.055 shares co-owned with Mr. Bone's father and siblings; and 0.0287 shares owned solely by Mr. Bone.
