Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

As previously disclosed in a Form 8-K filed on August 10, 2016 by Spark Networks, Inc. (the “Company”), the employment of Shailen Mistry, the Company’s former Chief Technology Officer, will terminate with the Company effective as of September 9, 2016. On September 7, 2016, the Company entered into a Separation Agreement and Release with Mr. Mistry, pursuant to which Mr. Mistry will receive severance payments consistent with the terms of his employment agreement with the Company, including (i) an amount equal to \$125,000, which is 50% of Mr. Mistry’s annual base salary, paid in equal installments on the Company’s normal payroll dates for a period of six months; (ii) a short-term annual incentive award in the amount of \$50,000; (iii) accrued but unused vacation of \$9,495; and (iv) reimbursement for COBRA payments paid by Mr. Mistry for 12 months. The foregoing summary of the Separation Agreement and Release does not purport to be complete and is qualified in its entirety by reference to such agreement, a copy of which is filed as Exhibit 10.1 hereto and incorporated herein by reference.
