On May 21, 2008 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 603 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest (1) in two equal annual installments on the first and second anniversary of the date of grant. On May 21, 2009, 302 shares of the originally granted RSAs vested, of which 89 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations.
