This Amendment No. 2 to Schedule 13G, is being filed with respect to the common stock, par value \$0.01 per share ("Common Stock"), of CRIS. The Reporting Persons' percentage ownership of Common Stock is based on 63,465,485 shares of Common Stock being outstanding and the beneficial ownership by the Reporting Persons of 658,050 warrants (the "Warrants") to purchase an equivalent number of shares of the Common Stock. See the discussion in footnote (1) for a further description of the Warrants.

As of December 31, 2008, BVF beneficially owned 1,366,699 shares of Common Stock, of which 150,759 shares are attributable to Warrants, BVF2 beneficially owned 934,681 shares of Common Stock, of which 103,051 shares are attributable to Warrants, BVLLC beneficially owned 3,437,336 shares of Common Stock, of which 359,887 shares are attributable to Warrants and ILL10 beneficially owned 394,375 shares of Common Stock, to which 44,353 shares are attributable to Warrants. Partners and BVF Inc. may each be deemed to beneficially own 6,133,091 shares of Common Stock, of which 658,050 shares are attributable to Warrants.
