PEACE ARCH ANNOUNCES PARTIAL REPAYMENT OF SUBORDINATED DEBT

VANCOUVER, BC Peace Arch Entertainment Group Inc. (AMEX: "PAE."; TSE: "PAE.A", "PAE.B"), which creates, develops, produces and distributes proprietary television programming for worldwide markets, today announced that it has retired \$1.2 million of its subordinated debt.

Earlier in December, Peace Arch announced it had refinanced a portion of its subordinated debt. In accordance with this agreement, all pre-payment penalties were waived.

"By making substantial repayments now, we are fulfilling our intention to repay or refinance these loans well before their maturity," commented Garth Albright, Chief Financial Officer of Peace Arch Entertainment Group Inc.

With this most recent payment, Peace Arch has reduced the total amount of subordinated debt outstanding to approximately \$4.5 million and expects to repay a further portion of these loans in the coming weeks.
