#### EXPLANATORY NOTE

On December 8, 1999, The Bear Stearns Companies Inc., a Delaware corporation (the "Company"), filed a Registration Statement on Form S-8 (File No. 333-92357) in order to register 16,000,000 shares of the Company's common stock, par value \$1.00 per share (the "Common Stock"), issuable under The Bear Stearns Companies Inc. Stock Award Plan (the "Stock Award Plan").

On March 29, 2001, the Company's stockholders approved an amendment to the Stock Award Plan to increase the number of shares as to which options or awards may be granted under the Stock Award Plan to a maximum of 24,000,000 shares of Common Stock. This Post-Effective Amendment No. 1 is being filed to register the additional 8,000,000 shares of Common Stock.

The registrant has in effect reimbursement insurance for directors' and officers' liability claims and directors' and officers' liability insurance indemnifying, respectively, the registrant and its directors and officers within specific limits for certain liabilities incurred by them, subject to the conditions and exclusions and deductible provisions of the policies.

In the event that a claim for indemnification against such liabilities (other than the payment by the registrant of expenses incurred or paid by a director, officer or controlling person of the registrant in the successful defense of any action, suit or proceeding) is asserted by such director, officer or controlling person in connection with the securities being registered, the registrant will, unless in the opinion of its counsel the matter has been settled by controlling precedent, submit to a court of appropriate jurisdiction the question whether such indemnification by it is against public policy as expressed in the Securities Act and will be governed by the final adjudication of such issue.
