(1) On September 16, 2008 and September 17, 2008, in accordance with a 10b5-1 Trading Plan, Morgan Stanley & Co., Incorporated, a registered broker-dealer, sold on behalf of Mr. Robert O. Carr, 74,900 and 5,100 shares, respectively, of the Common Stock of Heartland Payment Systems, Inc. (the "Company").

(2) This price is the weighted average price of the 53,500 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$24.47 to \$25.46. The reporting person will provide to the issuer, any security holder of the issuer or the SEC Staff, upon request, information regarding the number of shares sold at each price within the range of prices actually paid.

(4) This price is the weighted average price of the 21,400 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$25.47 to \$25.65. (5) This price is the weighted average price of the 5,100 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$24.63 to \$25.00. (6) After the sales, Mr. and Mrs. Carr beneficially own 5,600,499 shares of the Company's Common Stock and have a fully vested option to purchase an additional 125,000 shares of the Company's Common Stock.

(7) Mr. and Mrs. Carr's indirect beneficial ownership consists of 400,000 shares of Common Stock of the Company held by The Robert O. Carr 2001 Charitable Remainder Unitrust; 443,501 shares held by The Robert O. Carr 2000 Irrevocable Trust for Emily Carr and 400,989 shares held by The Robert O. Carr 2000 Irrevocable Trust for Kelly Carr. The reporting persons disclaim beneficial ownership of these securities, and this report shall not be deemed an admission that the reporting persons are the beneficial owner of the securities for purposes of Section 16 or for any other purpose.

(8) The reporting person no longer has a reportable beneficial interest in the 247,503 shares held by The Robert O. Carr 2000 Irrevocable Trust for Ryan Carr; 144,074 shares held by The Jill A. Carr 2000 Irrevocable Trust for Corriッサ Nichols; 144,994 shares held by The Jill A. Carr 2000 Irrevocable Trust for Robert Carr, Jr.; and 247,755 shares held by The Jill A.
