This Amendment No. 1 (the "Amendment") to Schedule 13D is being filed with the Securities and Exchange Commission (the "SEC") on behalf of OPKO Health, Inc., a Delaware corporation ("OPKO") and relates to the common shares, no par value (the "Common Shares"), of VBI Vaccines Inc. (the "Issuer"). This Amendment amends and supplements the initial statement on Schedule 13D (the "Original Schedule 13D") filed by OPKO with the SEC on March 31, 2017. Except as set forth herein, this Amendment does not modify any of the information previously reported by OPKO in the Original Schedule 13D. Unless otherwise indicated, all capitalized terms used herein have the meanings ascribed to them in the Original Schedule 13D.

#### ITEM 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended to add the following sentence immediately preceding the final paragraph: On October 30, 2017, OPKO acquired 655,738 Common Shares for an aggregate purchase price of \$2 million in a public offering being conducted by the Issuer.

#### ITEM 5. Interest in Securities of the Issuer.

Items 5(a)-(c) are hereby amended and restated to read as follows:

- (a) OPKO is the direct owner of 6,678,752 Common Shares or 16.6% of the Issuer's issued and outstanding Common Shares as of September 30, 2017, based on the Issuer's Prospectus Supplement as filed on October 27, 2017.
- (b) OPKO has the sole power to vote and dispose of the 6,678,752 Common Shares owned by it.
- (c) On October 30, 2017, OPKO purchased 655,738 Common Shares for a price per share of \$3.05 in a public offering being conducted by the Issuer.
