The Bank of New York Mellon Corporation, One Wall Street, New York, NY 10286, U.S.A., disclosed on February 13, 2014, that its total holding in Syngenta now amounts to 3,088,474 shares (3.32% of the total share capital), split into 3,054,012 registered shares plus purchase rights on ADRs (ISIN US87160A1007, 1 ADR=0.2 share) corresponding to 33,622 shares and short put options corresponding to 840 shares.
