On August 18, 2010, SRB Management changed its name to Becker Drapkin Management, L.P. ("BD Management"), Greenway Opportunity QP changed its name to Becker Drapkin Partners (QP), L.P. ("Becker Drapkin QP"), and Greenway Opportunity L.P. changed its name to Becker Drapkin Partners, L.P. ("Becker Drapkin LP"). Becker Drapkin QP and Becker Drapkin LP are referred to collectively as the "Becker Drapkin Funds." SRB Management, Greenway Opportunity QP and Greenway Opportunity L.P. are hereinafter referred to as BD Management, Becker Drapkin QP and Becker Drapkin LP, respectively.

This statement is jointly filed by and on behalf of each of BD Management, Becker Drapkin QP, Becker Drapkin LP, BC Advisors, LLC ("BCA"), Steven R. Becker ("Mr. Becker") and Matthew A. Drapkin ("Mr. Drapkin," and together with BD Management, Becker Drapkin QP, Becker Drapkin LP, BCA and Mr. Becker, the "Reporting Persons").

Becker Drapkin QP has the power to vote or to direct the vote of (and the power to dispose or direct the disposition of) the shares owned by it (the "Becker Drapkin QP Shares"). Becker Drapkin QP disclaims beneficial ownership of the Becker Drapkin LP Shares.

Becker Drapkin LP has the power to vote or to direct the vote of (and the power to dispose or direct the disposition of) the shares owned by it (the "Becker Drapkin LP Shares," and together with the Becker Drapkin QP Shares, the "Becker Drapkin Funds Shares"). Becker Drapkin LP disclaims beneficial ownership of the Becker Drapkin QP Shares.

As general partner of each of the Becker Drapkin Funds, BD Management may be deemed to have the shared power to vote or direct the vote of (and the shared power to dispose or direct the disposition of) the Becker Drapkin Funds Shares. BD Management does not own any shares of Common Stock directly and disclaims beneficial ownership of the Becker Drapkin Funds Shares.

As general partner of BD Management, BCA may be deemed to have the shared power to vote or direct the vote of (and the shared power to dispose or direct the disposition of) any shares of Common Stock beneficially owned by BD Management. BCA does not own any shares of Common Stock directly and disclaims beneficial ownership of any shares of Common Stock beneficially owned by BD Management.

As co-managing members of BCA, each of Mr. Becker and Mr. Drapkin may be deemed to have the shared power to vote or direct the vote of (and the shared power to dispose or direct the disposition of) any shares of Common Stock beneficially owned by BCA. Mr. Becker and Mr. Drapkin each disclaim beneficial ownership of any shares of Common Stock beneficially owned by BCA.

Each Reporting Person declares that neither the filing of this statement nor anything herein shall be construed as an admission that such person is, for the purposes of Sections 13(d) or 13(g) of the Act, the beneficial owner of any securities covered by this statement.
