Item 1.01 Entry into a Material Definitive Agreement.

In connection with the pending initial public offering (the <u>Offering</u>) of MetroPCS Communications, Inc. (the <u>Company</u>), which is anticipated to be a Qualifying Public Offering (as such term is defined in the Second Amended and Restated Stockholders Agreement (the <u>Stockholders Agreement</u>)), dated August 30, 2005, among the Company and the Stockholders (as defined therein) party thereto, on March 22, 2007, the Company received the approval of the requisite number of Stockholders for:

An amendment to the Stockholders Agreement (the <u>Amendment</u>), which (1) defines the rights of the Stockholders and holders of stock options to participate as selling stockholders in the Offering and (2) clarifies the limitations on sale or distribution by the Stockholders during the 180 day period following the Offering; and An amendment and restatement of the Stockholders Agreement, as amended by the Amendment (the <u>Registration Rights Agreement</u>), which (1) removes certain provisions of the Stockholders Agreement that terminate automatically upon consummation of a Qualifying Public Offering and (2) renames the Stockholders Agreement as a Registration Rights Agreement, such amendment and restatement to become effective upon the consummation of the Offering.

This summary does not purport to be complete and is qualified in its entirety by reference to the text of the Amendment and the Registration Rights Agreement, which are filed as Exhibits 10.1 and 10.2, respectively, to this report.
