**Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.**

On May 13 2008, Robert D. Campbell resigned as Senior Vice President and General Counsel of Noble Corporation (the Company ) in connection with his retirement from the Company.

In connection with Mr. Campbell s leaving the Company, the Company and Mr. Campbell have executed a Separation Agreement, dated May 13, 2008 (the Separation Agreement ). Under the Separation Agreement, Mr. Campbell will receive severance pay of \$300,000. The terms of the Separation Agreement further provide for a general release and other customary provisions. A copy of the Separation Agreement between Mr. Campbell and the Company is attached hereto as Exhibit 10.1
